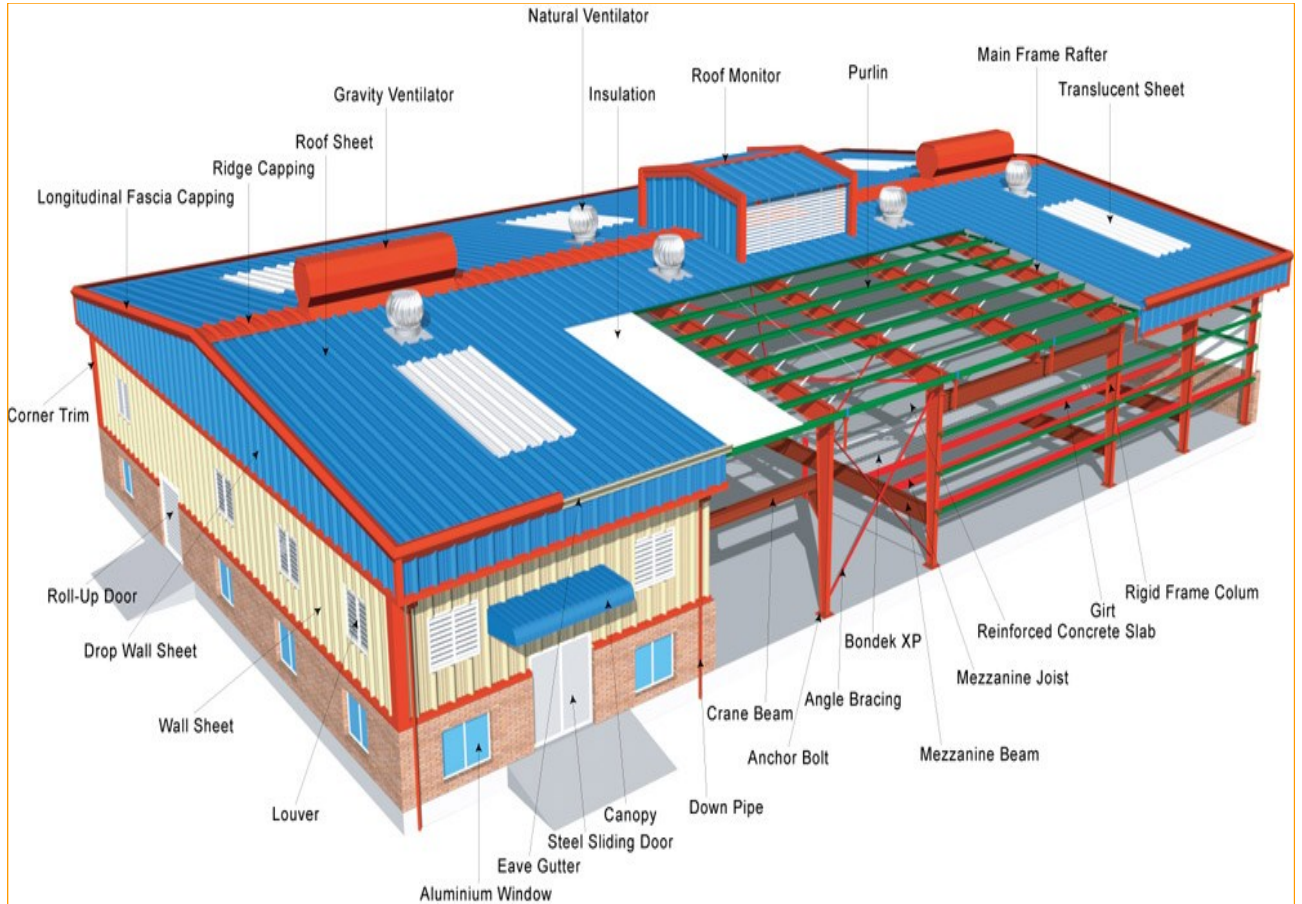

## **BASIC BUILDING PARAMETER:**

### **Building Length:**

Building Length is the sum of all bay lengths. For flush end wall, this is measured as the distance between outside flanges of two end wall columns on opposite end walls. For by-pass end walls, it is measured as the distance between outer faces of wall girt along two end walls.

### **Building Width:**

Width of a Building is defined as the distance between the outer sides of two eave struts along two sides of the building.

### **Building Height:**

Height of a building, usually termed as eave height is the height of top outer point of the eave strut from finished floor.

### **Roof Slope:**

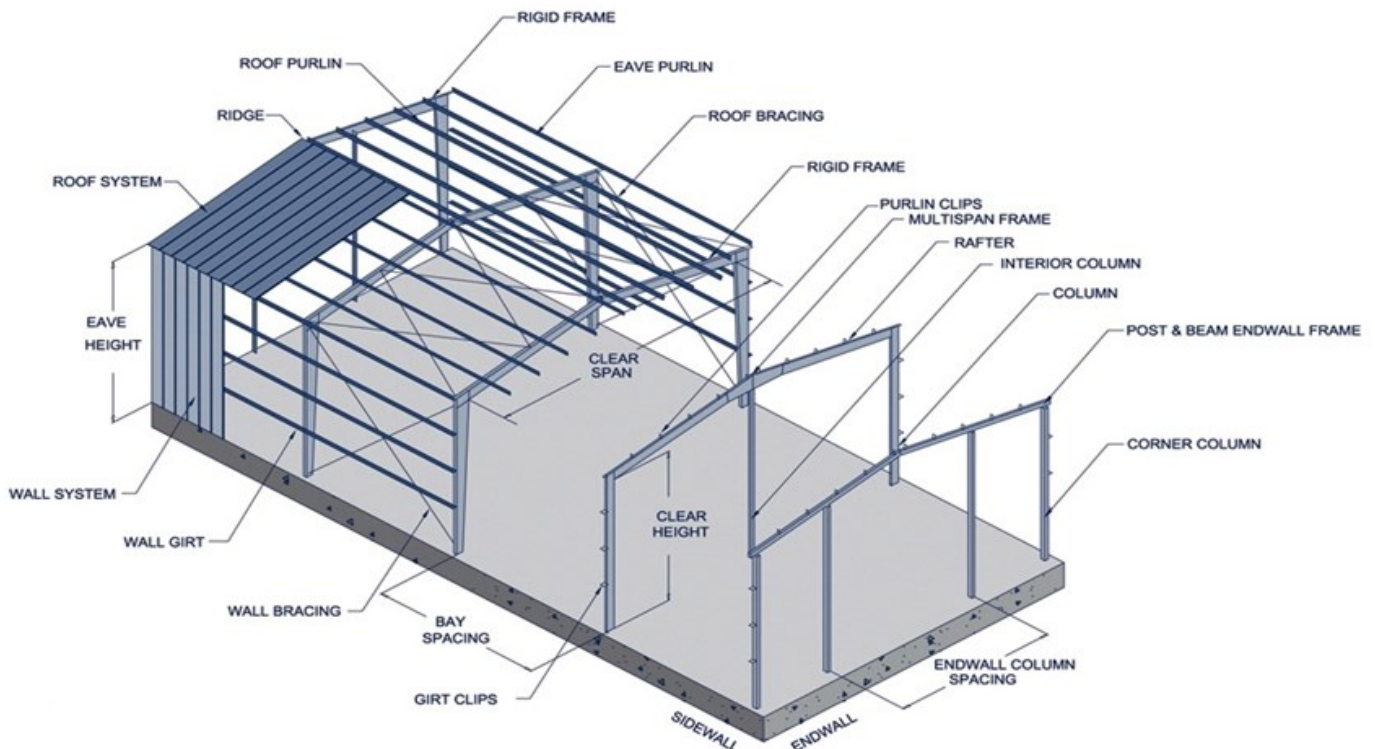
This defined as the angle between roofline with the horizontal. Any practical roof slope is possible. Most commonly used roof slope is 1:10 & 1:12.

### **Interior Bay Length:**

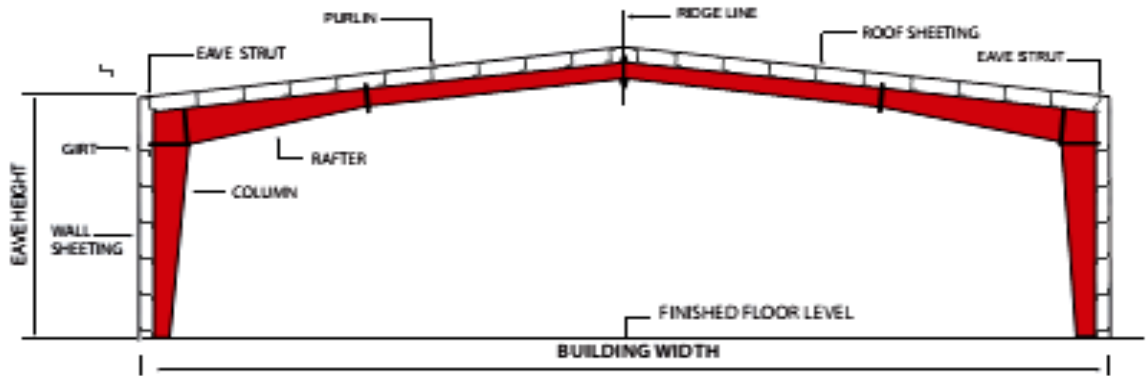
This is the distance between the center lines of two adjacent interior rigid frames. Most common interior bay lengths are 6m, 7.5m, 8m, & 9m.

### **End Bay Length:**

This is the distance from the center line of first interior rigid frame to outer flange of the adjacent end column (Flush system) or outside of end wall girt (By / Pass system).



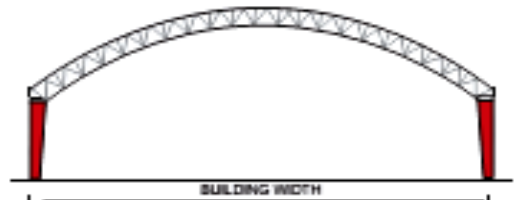

  4. To carry on the business of manufacturing every kinds of M.S. rod, angle, bar, plain and M.S. sheet, C.I. sheet etc. by establishing one or more steel mill or re-rolling mill & to carry on the business of manufacturing every kinds of electric wire by establishing one or more cable industry.
  5. To import or buy all and every kinds of raw materials, Chemicals, Computers, tools, implements, machines, mill-stores, spares, accessories, machineries, essential component parts, machine-tools, etc. whether manufactured by any local or foreign manufacturers or to trade or deal in every kinds of merchandise, commodities, materials, articles and produce of the soil of the country and to export or sale of all or any kinds of such goods, commodities, merchandise and also all sorts of machineries, tools, implements, spare-parts, essential component parts generally used by the Industries, factories, workshops whether belonging to the Company or



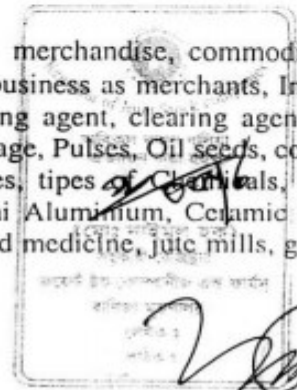


- other manufacturers or producers whichever may seem capable of being carried on advantageously in this line of Company's business.
6. **PRELIMINARY**

1. The Regulations contained in the Schedule-1 of the Companies Act. XVIII of 1994 (hereinafter called the Companies Act) shall apply to this Company with respect to such provisions as are applicable to Private Limited Company so far only as they are not negated or modified by or are not contained in the following Articles or any other Articles that may from time to time be framed by the Company or by any statute.

**PRIVATE COMPANY**


2. The Company is a Private Limited Company within the meaning of Section 2 (1) under Clause (q) of the Companies Act, 1994 and accordingly;
  - i. No invitation shall be issued to the public to subscribe for any shares or debenture of the Company.
  - ii. The number of the members of the Company (exclusive of the persons in the employment of the company) shall be Limited to fifty, provided that for the purpose of this provision when two or more persons hold one or more shares in the Company jointly they shall be treated as a single member, and
  - iii. The rights to transfer of shares of the Company shall be restricted in the manner and to the extent hereinafter appearing.

**COMMENCEMENT OF BUSINESS**

3. The company shall be entitle to commence business from the date of its incorporation.

**SHARE CAPITAL**

4. The Authorized Share Capital of the Company is Tk. 3,00,00,000/- (Taka Three Crore) divided into 15,000 (fifteen thousand) ordinary shares of Tk. 2000/- (Taka two thousand) each with power to increase or reduce the capital and to divide the shares for the time being into several classes and to attach there to such qualified or special right, privileges and conditions as may be determined by the Company and to vary, modify or abrogate any such rights, Privileges and conditions in such manner as may from time to time be provided by of higher or lower denomination.
5. The shares shall be under the control of the Board of Directors who may ~~pay~~ in cash or consideration other than cash or otherwise dispose of the same to such person in such manner or on such terms and conditions as the Board of Directors think fit.



### SHARE CERTIFICATE

6. The Certificate of title to share and duplicate there of when necessary shall be issued under the common seal of the Company and signed by Managing Director and any one of other directors jointly.

### TRANSFER AND TRANSMISSION OF SHARES

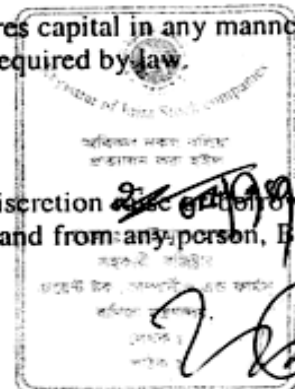

### BORROWING POWERS

firms, companies and particularly from any Director and may secure the payment of such money in such manner and upon such terms and conditions in all respects as they think fit and in particular by making, drawing, accepting or endorsing on behalf of the Company and promissory notes or bill of exchange of giving or issuing any other security of the Company and promissory notes or bill of exchange of giving or issuing any other security of the Company or by mortgage or charge of all or any property of the company including its uncalled capital for the time being and the Directors or any of them may guarantee the whole or any part of the loan or debts raised by on behalf of the company or any interest payable thereon with power to the Directors to indemnify the guarantors against any liability under their guarantee by means of mortgage or hypothecation of charge upon any property and assets of the Company immovable or movable or otherwise.

### GENERAL MEETING

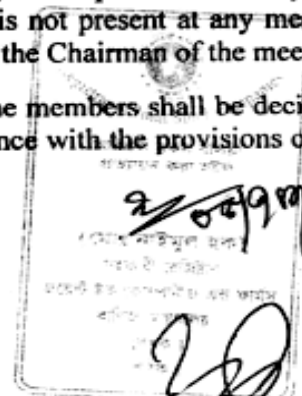
15. The first ordinary general meeting of the Company shall be held within eighteen months from the date of its incorporation, Subsequent general meetings shall be held once in every calendar year, (not being more than fifteen months after last general meeting). The general meetings referred to this articles shall be called "Annual General Meetings" All other meetings of the shareholders of the Company shall be called Extra Ordinary General Meetings. At least 14 days notice shall be required for annual general meeting. Time and place of all general meetings shall be decided by the Board of Directors from time to time.
16. The Directors may at any time call an Extra ordinary general meeting and an Extra ordinary general meeting may also be called by the Shareholders on requisition in accordance with the provisions of section 48 of the Companies Act, 1994.

### PROCEEDING AT GENERAL MEETING

17. Subject to the provision of section 87(2) of the Companies Act, 1994, relating to special resolution at least 14 days notice shall be given specifying the day, place and the hour of the meeting and the subjects and business to be transacted in the meeting. But in case of special business the general nature of that business shall be given in the manner herein above. The accidental omission to give notice to or the non-receipt of the notice by any member shall not invalidate the proceeding of any General Meeting.

### QUORUM

18. No business shall be transacted at any general meeting unless the quorum of members is present at the time when the meeting proceeds **2 (two)** members present in person shall form the QUORUM for general meeting.
19. The Chairman of the Board of Directors (if any) shall preside at every general meeting. If there is no such Chairman or if he/she is not present at any meeting the members present shall choose any one of them to be the Chairman of the meeting.
20. In any general meeting a resolution put to vote of the members shall be decided by a show of hands unless a poll is demanded in accordance with the provisions of section 85-1 (Ga) of the Companies Act, 1994.



### VOTES OF MEMBERS

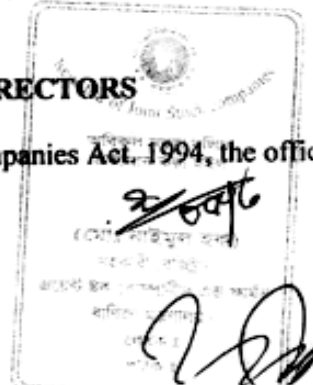
21. On a show of hands every member present in person shall have one vote, on a poll every member present in person or by proxy shall have one vote in respect of each share held by him/her.

25. The **qualification of Director** shall be holding of 500 shares of Tk. 2000/- each in the capital of the Company in his/her own name alone and not jointly with others.
26. Unless otherwise determined by the company in a general meeting each Director shall receive a sum not exceeding Tk. 500/- (Taka five hundred) only for every meeting of the Board of Directors attended by him/her with such travelling, holding charge incurred by him/her.
27. If any Director when willing be called upon to perform any extra service or to make any special exertion for any of the purpose of the Company, the Company may remunerate the Directors so doing either by a fixed sum of percentages of the net profit or otherwise as may be decided by the Company in general meeting and such remuneration shall be in additions of the remuneration in Articles No. 26.
28. In provision of section 90 & 91 of the Companies Act, 1994, the Director shall have power from time to time to appoint one or more person as Directors who shall retire from office at the next ordinary general meetings as directors provided that by such appointment the total number of directors shall not exceed the maximum number fixed by the Article No. 23.

### DISQUALIFICATION OF DIRECTORS

- e) without the sanction of the Company general meeting accept or hold any office of profit under the Company other than that of a managing director or manager or a legal or technical adviser or banker; or
- f) absents him self from three consecutive meeting of the Directors or from all meetings of the Directors for a continuous period of three months whichever is longer without leave of absence from the Board of Director.

#### POWERS AND DUTIES OF DIRECTORS

30. The business of the Company shall be managed by the Managing Directors who may pay all such expenses incurred in getting up and registering the Company and may exercise all such powers of the Company as are not forbidden by the Companies Act, 1994 or any statutory modification thereof for the time being enforce or by these articles. Required to be exercised by the Company in general meeting shall invalidate any prior act, of the Directors which would have been valid if that regulation had no been made.

#### PROCEEDING OF DIRECTOR

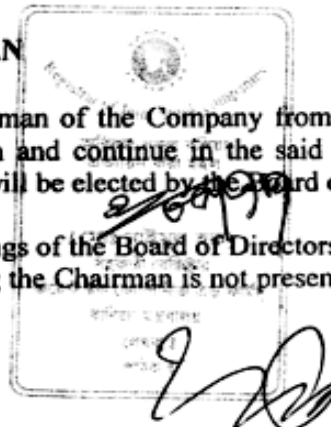
31. 35. The Chairman shall preside over all the meetings of the Board of Directors but if there is no permanent chairman or if at any meeting the Chairman is not present at the time



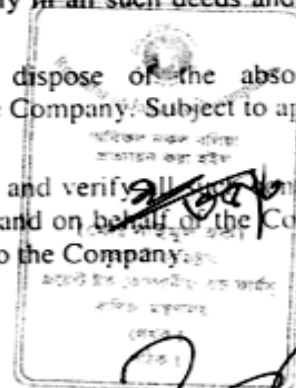
appointed for holding the same, the Directors present may choose one of the members to be the Chairman of the meeting.

### MANAGEMENT AND MANAGING DIRECTOR

36. Subject to the control and supervision of the Board of Director the business and all other affairs of the company shall be managed by the Managing Director of the Company.
37. **Baharul Islam Talukder** shall be the first Managing Director of the Company from the date of incorporation. He shall be entitled to remain and continue in the said office for a period of 5 (Five) years. The next Managing Director will be elected by the Board of Directors.
38. For the service to be render by the Managing Director, he/she shall receive such allowances and remuneration as will be determined by the Board of Directors from time to time.

  - To purchase or otherwise acquire for the Company any property, right privileges such as the Company authorized to such price and generally on such terms and conditions as he thinks fit. Subject to approval of the board.
  - To sign cheques, certificate, drafts, and other documents on behalf of the Company.
  - To execute and sign in the name of the company in all such deeds and things as are necessary for the welfare of the Company.
  - To purchase, sell, exchange or otherwise dispose of the absolutely or conditionally any property for the purpose of the Company. Subject to approval of the board.
  - To enter into all such negotiations and contract and verify all contracts and execute and do all such act, deeds in the name and on behalf of the Company as he/she may consider expedient for any relation to the Company.



- h) To delegate all or any of the powers hereby conferred upon him to any Directors, manager, secretary or the officers of the Company as he may from time to time think fit and proper.

#### OPERATION OF BANK ACCOUNT

40. The company shall open Bank Account with any schedule Commercial Bank/Banks and Managing Director of the company shall operate the bank accounts singly.

#### NOTICE

41. When a notice is sent by registered post, service of the notice shall be deemed to be effectual by properly addressing, prepaying and posting a letter containing the notice and unless contrary is proved to have effect at the time which the letter would deliver by post & regulations No. 113 to 117 of schedule-1 shall apply.

#### THE COMMON SEAL

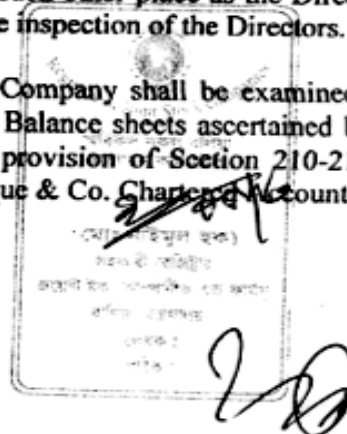
42. The Common Seal of the Company shall not be affixed to any instrument except by authority of a resolution of the Board of Directors and in presence of one Director who shall sign every instrument to which the common seal of the Company is so affixed.

#### DIVIDEND AND RESERVES

43. The company in General Meeting may declare dividends but no dividend shall exceed the amount recommended by the Directors.
44. The Directors may from time to time, pay to the members such interim dividends as appear to the Directors to be justified by the profits of the company.

#### ACCOUNTS AND AUDIT

45. The Directors shall cause true accounts to be kept in provision of section 181 & 182 of the Companies Act, 1994 and shall provide the section 181-191 of the Companies Act, 1994.
- Of all sales and purchases of goods by the company.
  - Of the assets and liabilities of the Company, and
  - Of all sums of money received and expended by the company and the matters in respect of which such receipt and expenditure take place. The Books of accounts shall be kept at the Registered office or at such other place as the Directors may think fit and shall always be kept open to the inspection of the Directors.
46. Once at least every year the Accounts of the Company shall be examined and the correctness of the profit and loss Account and Balance sheets ascertained by one or more auditors appointed for the purpose and provision of Section 210-213 of the companies Act, 1994. M/s. K. M. Alam, Khalque & Co. Chartered Accountants shall be the 1st Auditors of the Company.



47. The remuneration of the auditors shall be fixed by the Company in general meeting except that the remuneration of any auditors appointed by the Board of Directors be fixed by them, under sub-section 10 & 11 of Section 210 of the Companies Act, 1994.

#### INDEMNITY

48. The Chairman, managing Director and Directors, Officer, Servant shall be indemnity by the Company for all losses and expenditure incurred by him or them respectively in or about the discharge of their duty except their willful act, neglect or default and shall be the duty of the company to pay out of its fund in cash all losses and expenses which the Managing Director or any other directors, officers or servants may in any way incur in the discharge of his or their duties and the amount for which indemnity is provided shall immediately attach a lien on the property of the company and have priority over all claims.

#### SECRECY

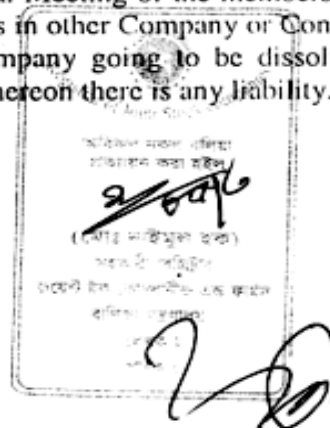
49. The Chairman, Managing Director, Director, Manager, Secretary, Auditor, Accountants, Officer, Agent or other person employed in the business of the company shall have to observe strict secrecy responding all matters which may come to his knowledge in the discharge of his duties when required to do so by resolution of the company or by a court of law or where the person connected is required to do so in order to comply with any provision of the law or in the presents.

#### ARBITRATION

Arbitration affairs will be dealt and settled under the arbitration act. 2001.




#### WINDING UP

51. If the Company shall be winding up, the surplus assets (subject to any rights attached to any special class of shares forming part of the capital for the time being) of the company applied first in the payment of capital paid up on the shares, and the excess (if any) shall be distributed among the members in proportion to the number of shares held by them respectively at the commencement of winding up.
52. With the sanction of an Extra Ordinary General Meeting of the members any part of the assets of the Company including any shares in other Company or Companies may be divided between the members of the Company going to be dissolved, but no member shall be compelled to accept shares whereon there is any liability.







